

Marshfield Area United Way House Raffle Official Rules

The Marshfield Area United Way House Raffle (“Raffle”) begins on May 2, 2011 and ends on June 4, 2011 (“Raffle Period”). The Raffle is conducted by Marshfield Area United Way, 156 South Central Ave P.O. Box 771, Marshfield, WI 54449 (“MAUW”). The Official Rules of the Raffle are set forth herein. By entering the Raffle, Entrants agree to be fully and unconditionally bound by these Official Rules, waive any right to claim ambiguity in the Raffle or these Official Rules and further agree to be bound by MAUW’s decisions and interpretation of these Official Rules.

Void where prohibited by law.

- 1. Eligibility.** The Raffle is open to all persons age 18 and over who are legal U.S. residents physically residing in the United States or D.C. Employees and Board Members and anyone that lives in the same household as an employee or board member of the Marshfield Area United Way are not eligible to participate and/or win any prize associated with the Marshfield Area United Way House Raffle.

If there is more than one name on an entry, the prize will be awarded to the first name listed on the entry as the winner, so long as that person is eligible. It is the sole responsibility of the winner in a multiple party entry to allocate any prize among the participants in that entry.

- 2. How to Enter.** Raffle tickets (“Tickets”) cost \$50.00 individually or three or more tickets purchased at the same time for \$33.33 per ticket. Here is how to purchase Tickets and enter the Raffle:
 - a. Purchase from Marshfield Area United Way or a representative of Marshfield Area United Way, or through a ticket outlet location.

TICKETS CANNOT BE PURCHASED ONLINE OR BY E-MAIL BY PHONE OR BY MAIL.

A maximum of five thousand (5,000) tickets will be issued and available for purchase. Subject to availability, Entrants may purchase as many Tickets as they wish. Tickets, receipts and the winner’s rights are not transferable.

MAUW reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered Entry Forms and entries that do not include valid or complete payment. MAUW is not responsible for printing

errors in any Raffle related material. All entries become the property of MAUW and will not be returned.

3. **Drawings.** Three (3) random drawings will be conducted by two representatives of MAUW. The drawings will be held on June 4, 2011 at 3:30 p.m. CST at the Marshfield Fair Park, 513 East 17th Street, Marshfield, Wisconsin. The drawings will be open to the public. All drawings for prizes shall be made at random. Winners need not be present to win.

4. **Notification.** The Entrant whose Ticket number is drawn at the Drawings will be deemed the winner of a prize (“Selected Entrants”). The Selected Entrants will be notified in writing with the Winner Notification Agreement, (“Agreement”), which will be sent by certified, return receipt U.S. Mail using the information provided on the Entry Form or by phone (“Notification”). The Selected Entrant will have seven (7) business days from the date of receipt of the Winner Notification Agreement to accept the prize by executing and returning the Agreement pursuant to the terms stated therein. Failure to execute and return the Winner Notification Agreement and accept the prize timely, and pursuant to the terms stated in the Agreement, will automatically result in forfeiture of the prize, with no substitution or alternative prize available to the original Selected Entrant. In the event of forfeiture, another raffle ticket will be selected and will be awarded the prize. Acceptance of a prize is permission for the Marshfield Area United Way to use the name, photographs/likeness, and relevant quotes of the Selected Entrant and agreement that the prize will not be used for further fundraising.

5. **Prize**
One (1) Grand Prize Drawing: The Grand Prize winner will receive the Grand Prize according to the following ticket sale, depending on the number of Tickets sold as of the end date of the Raffle:

Tickets Sold	Prize
0 – 3,749	An amount equal to 50% of the total Ticket proceeds received by MAUW minus all costs and expenses paid or incurred by MAUW in connection with the Raffle.
3,750 – 5,000	Wisconsin Homes Cavalier Model 2850 and package as defined below <u>or</u> \$50,000 cash prize.

If 3,750 to 5,000 tickets are sold, the Grand Prize Selected Entrant will win a Wisconsin Homes Cavalier –Model 2850 and \$25,000 in cash towards construction/set expenses associated with the accepting the prize. Marshfield Area United Way and Wisconsin Homes, Inc. are not responsible for any costs incurred in excess of awarding the Grand Prize House and \$25,000.00. The Grand Prize House does not include a lot or land, nor foundation, construction or set expenses that are associated with accepting the Grand Prize House. Appliances and furnishings are also not included with the Grand Prize House. Wisconsin Homes, Inc. will waive the freight fee if the Grand Prize House is being delivered within fifty (50) miles of Marshfield, Wisconsin. The Winner will have up to 140 days from the drawing date of June 4, 2011 to accept delivery of the house. The house may be built anywhere in Wisconsin, Minnesota or Iowa. The Winner may not trade the house for a cash equivalent.

The winner is subject to all Federal and State income taxes and any other taxes payable due to the acceptance of the prize and the law, regulations, procedures, rules and directives applicable to raffles. All federal, state and local laws relating to the transfer, ownership or use of the prize applies. Prize shall not be transferred until all legal requirements have been met. Winner of the house agrees that the written determination by Wisconsin Homes for the value of the Model 2850 will be used to determine the value of the house for income tax, property tax and any/or all other purposes. **The IRS requires that taxes on Prizes valued greater than \$5,000 must be Paid upon acceptance and before the Marshfield Area United Way may deliver the Prize to the winner. Winners are encouraged to consult a tax professional.**

One (1) Second Place Drawing: Cash Prize of \$3,000.000

One (1) Third Place Drawing: Cash Prize of \$1,000.00

Cash prize will be delivered to Selected Entrant by U.S. registered mail to the name and address provide on the Entry Form. Payment will be done in the form of a check made payable to the name provided on the Entry Form. Selected Entrants will receive an IRS Form 5754 and a W2-G.

6. **Proceeds.** Proceeds from the Raffle will benefit Marshfield Area United Way and its ongoing charitable purposes.
7. **Odds.** Odds of winning depend on the number of Raffle Tickets sold. If 5,000 are sold, the odds of winning a Prize is 3:5,000.
8. **General Conditions.** The Raffle is subject to these Official Rules. These Official Rules shall not be changed by any oral statement made by any employee or other person acting on behalf of Marshfield Area United Way. By participating, Entrants agrees: (i) to be bound by these complete Official Rules and the decisions of Marshfield Area United Way which shall be final and binding; and (ii) to waive any rights to claim ambiguity in the Raffle or these Official Rules, except where prohibited by law. By accepting a prize, a Selected Entrant agrees to release Marshfield Area United Way and Wisconsin Homes, Inc. , its officers, directors, employees, representatives and agents, and any person or entity associated with the production, judging, or administration of the Raffle (collectively the "Releasees") from and against any claims, damages, liability, attorney's fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from redemption, acceptance, possession, ownership, misuse or use of any prize or participation in any Raffle-related activity or participation in the Raffle. Except where prohibited by law, the Selected Entrant's purchase of a Raffle Ticket and acceptance of a prize constitutes permission for MAUW to use said Selected Entrant's name, photograph, likeness, statements, biographical information, voice, and city and state address for promotional or advertising purposes in connection with this Raffle on a worldwide basis, and in all forms of media, now or hereafter known in perpetuity, without review, permission or further compensation. Taxes, if any, are the sole responsibility of Selected Entrant and the Selected Entrant will be issued an IRS 5754 and W2-G for the Estimated Retail Value of any awarded prize. Each ticket purchaser is advised to consult his or her own tax advisor(s) with respect to the tax liabilities that may arise from winning a prize in this Raffle. Marshfield Area United Way reserves the right to disqualify any entrant it finds to be tampering with the entry process or the operation of the Raffle or violating these Official Rules, and reserves the right to cancel the Raffle should it suspect fraud or for reasons out of the control of MAUW. Disputes regarding these Official Rules and/or this Raffle will be governed by the internal laws of the State of Wisconsin.

- 9. Privacy.** All personal information collected by MAUW will be used for the administration of the Raffle. MAUW will not share, sell or otherwise distribute personal information collected by MAUW except as stated above.
- 10. Official Rules and Winner's List.** These Official Rules will be posted on the website of Marshfield Area United Way www.marshfieldareaunitedway.org and the prize winners will be posted on the above website on June 6, 2011. A copy of the winner's list and of these Official Rules may be obtained by sending a self-addressed, stamped envelope to: Marshfield Area United Way, P.O. Box 771, Marshfield, WI 54449. Requests must be received within 30 days of the close of the Raffle.
- 11. Registration with the State of Wisconsin.** Marshfield Area United Way has registered with the Department of Administration under Raffle License Number R0018329A – 13061 and is authorized to conduct raffles in Wisconsin for the period which begins 3/1/2011 and ends 2/29/2012.
