2022 GIVE & WIN Sweepstakes Rules

- 1. **TIMING:** This incentive promotion includes 2022 Marshfield Area United Way Campaign donations made through 4:30 p. m. Central Time on Friday, December 16, 2022. To be eligible for the 2021 GIVE & WIN Sweepstakes, participants must be legal residents of Wisconsin, at least 18 years of age, AND possess a valid Wisconsin driver's license.
- <u>2. PRIZES:</u> Winners will receive one of four \$1000 cash prizes. Odds of winning depend on number of eligible entries received. Four cash prizes are donated to Marshfield Area United Way by: Nasonville Dairy, Simplicity Credit Union, and Badger Title.
