

# 2025 GIVE AND WIN SWEEPSTAKES RULES

1. **TIMING:** This incentive promotion includes 2025 Marshfield Area United Way Campaign donations made through 12:00PM Central Time on Friday, December 12, 2025. To be eligible for the 2025 GIVE & WIN Sweepstakes, participants must be legal residents of Wisconsin, at least 18 years of age, AND possess a valid Wisconsin driver's license.

2. **PRIZES:** Winners will receive one of four \$1000 cash prizes. Odds of winning depend on number of eligible entries received. Four cash prizes are donated to Marshfield Area United Way by Nasonville Dairy.

3. **ELIGIBILITY:** Employees of Marshfield Area United Way and their immediate families are not eligible to participate. Only individuals are eligible for the 2025 GIVE & WIN Sweepstakes; organizations are not eligible. Out of area campaigns that are processed by but not counted toward the Marshfield Area United Way campaign are not eligible. Online entries will not be accepted.

Any Marshfield Area United Way donor that makes an unrestricted gift of \$52 (or \$1 per week) in 2025 (exclusive of any employer match) will be automatically entered into the GIVE & WIN Sweepstakes for FIFTY (50) chances to win. Or, Donors who gave at least \$52 or more to the 2024 Marshfield Area United Way campaign and increases his or her gift by \$1 or more in 2025 will be automatically entered into the GIVE & WIN Sweepstakes for ONE HUNDRED (100) chances to win. Entry without donation for the GIVE & WIN Sweepstakes can be made by sending up to 100 entries on 4"x 6" cards (10 entries per envelope) to Marshfield Area United Way, ATTN: 2025 GIVE & WIN Sweepstakes, PO Box 771, Marshfield, WI 54449, containing name, address and phone number. A limit of ONE HUNDRED entries per person, automatic or otherwise, allowed for the GIVE & WIN Sweepstakes.

4. **ENTRIES:** Entry letters must be postmarked and pledge forms, eligible donations and eligible employee lists must be received by Marshfield Area United Way by 12:00PM Central Standard Time on December 12, 2025. Marshfield Area United Way will not be responsible for individuals or companies that fail to submit their employees pledge forms, eligible donations or list of eligible employees by this date. United Way is not responsible for lost or misdirected mail.

5. **DRAWING & ANNOUNCEMENT:** The potential winners of the sweepstakes will be drawn (randomly) from all valid entries prior to January 31, 2026, at the Marshfield Area United Way office. The potential winners will be required to provide proper photo identification and verification of compliance with these Official Rules prior to award of the prize. If the potential winner does not meet these eligibility requirements or is not in compliance with these Official Rules, the potential winner will be disqualified and an alternate winner will be selected. The name of the prize winner will be announced on the Marshfield Area United Way's website before February 28, 2026.

6. **REQUIRED INFORMATION:** Winners receiving prizes valued at \$600 or more are required to provide their home address and Social Security Number and to comply with these Official Rules upon presentation of prize.

7. **RELEASE:** By entering, all participants hereby agree to comply with these Official Rules, represent that he/she is eligible, and consent to the use of his/her name and/or photograph for publicity purposes without further compensation, unless prohibited by law. All entrants release Marshfield Area United Way and each donor company listed in section 2 above; their respective employees, directors, officers and agents; their respective parent, subsidiary and affiliated companies; and their respective advertising, fulfillment, publicity and promotion agencies from any and all claims or liability in connection with their participation in this promotion.

8. **RECEIPT OF PRIZES:** The prize may not be substituted for any other prize except by Marshfield Area United Way due to unavailability. Marshfield Area United Way reserves the right to cancel, terminate or modify; this promotion if not capable of completion as planned.

9. **RESPONSIBILITY:** Winners will be required to pay any applicable taxes and costs relating to the transactions, including, but not limited to, federal and state income taxes. Participation in this promotion may affect the tax deductibility of your gift. You should consult your tax advisor for more detailed information.

11. **ENTRY INTEGRITY:** Those individuals that qualify for the \$1,000 Cash Prize Drawing are automatically and systematically (not manually) entered into the drawing as their pledges are processed. Participating public sector campaigns do provide individual donor information, which is audited, so public sector qualifiers can be assured they will be included and there is little room for human error. Companies, who do not typically provide individual pledge information, may submit a list of those employees who have qualified. Those names are added to the data base of automatic qualifiers. Additionally, those people who submitted an entry outside of the automatic qualification process are also entered into the data base. Although we cannot publish the list of all those who qualify, if a workplace campaign requests a list of qualifiers from their own company, Marshfield Area United Way can provide it prior to the drawing, but after all pledges received by December 12, 2025, have been posted.
